

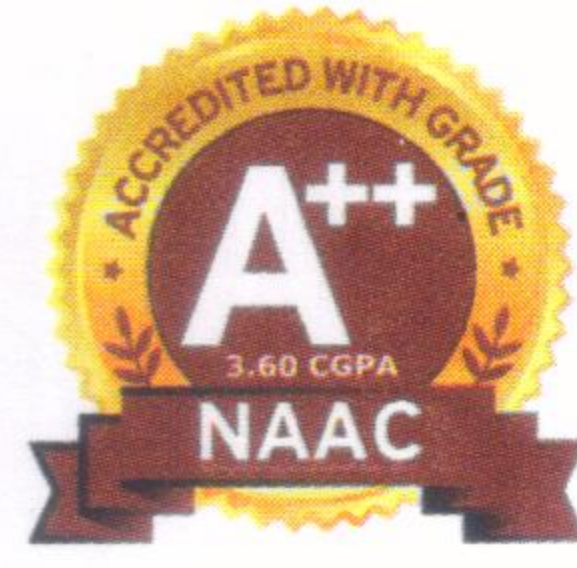

The CSU reserves the right for inspecting your institution at any time and withdraw affiliation even during the academic session if the institution's activities/functioning found against the guidelines applicable to the institutions affiliated to Central Sanskrit University, Delhi.

The renewal of this affiliation is subject to the institute maintaining a minimum enrollment of 20 students. Additionally, the institute may not be designated as an examination center for its own students. However, to qualify as an examination center, the institute must have a minimum of 15 students.
